For POL 377 and 380, employ lecture and seminar format. Students must turn in a mandatory draft of their semester paper, read other students' drafts, present their work to the class, and rewrite their paper based on student and instructor comments. Students must also submit a cumulative, take-home final exam.

For POL 409, employ a seminar format. Students must submit two review essays (each on a book read for class), lead classroom discussion on two occasions, turn in a mandatory draft of their semester paper, read other students' drafts, present their work to the class, and rewrite their paper based on student and instructor comments. Students must also submit a cumulative, take-home final exam.

In POL 360, prepare class for participation at the Model United Nations Conference of the Far West in San Francisco, CA. In 2002, students represented Canada; in 2003, Iran and Bahrain; in 2004, Canada (which earned a delegation certificate award for pre-conference work), the United Kingdom, Saudi Arabia, and Libya; in 2005, Germany, South Africa, Turkey, and Australia (earned delegation certificate); in 2006, Italy and Pakistan (both of which earned delegation certificates); in 2007, Cuba and Turkey; in 2008, Russia and Egypt (both of which earned delegation certificates); and in 2009, Canada, Iran, and Ireland (all three of which earned delegation certificates).
